- 1. The Council CONGRATULATED Mr. David P.W. LAU on his re-election to the Council and EXTENDED a warm welcome to the five new Council members, The Hon. Rock C.N. CHEN, Mr. Simon T.C. LI, Mr. Irons SZE, Mr. Wilfred K.P. WONG and Dr. Samuel W.K. YUNG.

- 3. The Council HEARD a report from the President & Vice-Chancellor on the following:

 - (c) the recent establishment of the School of Innovation;
